Seventy Years Ago 1938

Fall Marriage Licenses in Cass County (Excerpt from Cass County Independent, January 6, 1939)

Dan Cupid was thrown for a loss in Cass County during 1938 as compared to 1937, according to a complete tabulation of marriage licenses issued by Clerk of Courts, A. K. McPherson. During 1938, 157 couples made application for licenses as compared with 178 for 1937, a decrease of 21.

June, the traditional month of weddings outranked all the other months with 22 intentions filed. The heart throbs are decidedly fewer during mid-winter and is apparent from an examination of the figures by month. Only 23 licenses were issued in the first three months of the year. Dan Cupid seems to be more lethargic during the winter months and gets in his biggest turnover during the late spring and late summer months.

Volunteers to help collect obituaries from past and present newspapers. One can cut and paste from a collection of current papers or read old papers and put the information on index cards to add to our database. The goal is 25,000 obituaries. Elsie Nelson has been coming in regularly as a volunteer to assist with the office work and Bev Sheldon is working on the database.

With some astonishment, I realized this week while cleaning and organizing some old files that the newsletter *Cass County Clippings* is in its 9th year of publication. How time flies when you're having fun!

ONGOING PROJECTS

Cec McKeig organized 3700 school cards into a database, purchased storage boxes and placed them into a card file. A date of 8th grade graduation is recorded on some cards but is missing on others. In some cases, the card only records a period of attendance at the school. Some cards have only a name and date, and should not be construed as complete. Others have the parent's name as well as the school. We know that many cards are missing.

Cec organized 1775 teacher records into a database. The database has been printed out. The cards were sorted and placed into a card file. We were no sooner finished than the first visitor at the Research Center came along and asked about a family member who had been a teacher in Cass County.

Cec extracted 3500 employee names from the Ah Gwah Ching box holder ledger with dates of box holder rentals. In some cases, the employee only rented a box for a three-month period, but it will place the employee in that job at that period of time. For example, Luzias Luzi rented a postal box from 1933-1934. The only other reference to him in a search on the internet places him in Minneapolis as a cook from 1932-1933. It is likely that he took a short term position at Ah Gwah Ching as a cook as well. There are names of teachers in both the teacher database and the Ah Gwah Ching database.


One of our immediate goals is to expand the microfilm collection of newspapers and census records as we have the only microfilm reader/printer available for public use in the county.

LEGACY GRANT

The Legacy Grant Project ended on September 30th. We completed ten interviews with elders of the Onigum area and scanned approximately 300 pictures of people and places of the area. A Cemetery Transcription database for the St. John Episcopal Cemetery and the Old Catholic Agency Cemetery was added to the project. A day-long walk on August 9th with GPS technology enabled us to produce a GPS map of the area. The project will be showcased at the Minnesota Indian Education Conference at Mahnomen on October 8th and 9th. Photos show part of the original foundation of the Superintendents home at the Leech Lake Indian Agency; a cover from the original septic system at the government agency; a view of part of the original dock piling for the government dock; an old nail found near the dock access; the bell that was used at the agency for emergencies or to summon students; and a cornerstone of the foundation of the Onigum General Store.


















WALKER HISTORY WALK

RESORT FILES

Jolene Safranek is organizing reams of information gleaned from county newspapers on the history of early Cass County resorts. The majority of information gathered so far is on northern Cass County. We have some information on resorts in southern Cass, but looking for volunteers to expand the collection. Also needed are photos and postcards as most of these resorts are no longer operating. Photos will be scanned and returned. Mr. and Mrs. David C. Hintz recently shared postcards from the Whipholt area.

CASS COUNTY RESEARCH CENTER

Every once in a while we get a call to aid law enforcement in solving a case. This August we got a call from the National Center For Missing and Exploited Children Cold Case Unit. Robert Hanson, the "Aviator Killer" from Alaska, was apprehended and sentenced to life in prison for the murders of four teenage girls there. While incarcerated, he spoke of murdering two boys in the Walker area in 1963 at a local resort. Investigators called and asked for our help in substantiating this claim. Renee Geving researched our resort files and found that his parents owned a local resort from 1963 to 1965. She also spoke with Onigum residents and found that no one knew of any missing 16-year-old boys in 1963. Renee forwarded this information to the Cold Case Unit in Montana.
